Mechanics and Terms & Conditions – Lucky \$5 Note

Mechanics:

Each week of the promotion The Wave staff will keep a record of a serial number from a regular Australian five dollar note, which will then be referred to as the 'Lucky \$5 Note' (serial numbers being unique to each note).

The 'Lucky \$5 Note' will be distributed to a local retailer, somewhere in the 91.7FM The Wave listening area.

Distribution of 'The Lucky \$5 Note' will take place each weekend (being either a Saturday or a Sunday). Retailers will be unaware of the significance of the transaction.

The weekly serial number of the 'Lucky \$5 Note' will be valid for a total of five consecutive days only (9:01am Monday to 4:00pm Friday) and the prize must be claimed within this time. The weekly competition will finish early when the prize money is claimed or to the station's discretion.

Listeners will be told the weekly 'Lucky \$5 Note' serial number on air at various times and online at www.917thewave.com.au, throughout the week of the competition (Monday to Friday).

Entrants will need to check their own five dollar note serial number against each weeks 'Lucky \$5 Note' serial number to see if they have the winning five dollar note.

If the entrants five dollar note serial number matches the current 'Lucky \$5 Note' serial number for that particular week, they must provide 91.7 The Wave proof of this by bringing their five dollar note to the station during business hours for the note to be verified. Upon verification of the \$5 note and current identification (driver's license, passport or bank statement with address), the entrant will win the prize money.

91.7 The Wave is located at 141-143 Mandurah Terrace, Mandurah WA 6210. Business hours are 9:00am to 4:00pm Monday to Friday, excluding public holidays.
