1. General

- 1.1 By participating, entrants agree to be bound by these Terms and Conditions. All instructions, promotional material, advertising and on-air announcements relating to this competition form part of these Terms and Conditions. The Promoter's decision is final, and no correspondence will be entered into.
- 1.2 The Promoter is West Coast Radio Pty Ltd, licensee of 97.3 Coast FM. Entry is open to residents of Western Australia only, excluding employees of West Coast Radio Pty Ltd, employees of participating sponsors, and immediate family members of such employees. "Immediate family" includes spouses, de facto partners, parents, stepparents, siblings, children, grandchildren and any person residing in the same household. The Promoter reserves the right to verify the eligibility of all entrants.
- 1.3 The Promoter reserves the right to change or amend these Terms and Conditions at any time, without notice.

2. Promotional Period

- 2.1 The promotion runs from Monday 1st December 2025 and concludes at the final event on Thursday 5th March 2026.
- 2.2 The promotional format includes on-air, online, QR-entry and in-person activations encouraging listener participation across the promotional period.

3. How to Enter

- 3.1 There are three (3) ways to enter the 97 Days of Summer promotion to get on the standby list:
- (a) Prize Winners: Any listener who wins a prize on 97.3 Coast FM from 1st December 2025 through until 27th February 2026 automatically receives one (1) entry into the draw.
- (b) QR Code Entry: Listeners may enter by scanning the QR Code at participating 97 Days of Summer client businesses or at official Coast Crew Summer activations.
- (c) Cue to Call: Daily Standby List: From Monday 1st December 2025 until Friday 23rd January 2026 (excluding public holidays) listeners may enter by calling during the weekday Cue to Call (one per weekday excluding Public Holidays). The correct caller through during the cue will be added to the Daily Standby List.
- 3.2 Entrants may only submit one valid entry per entry method. Additional, duplicated or fraudulent entries may be disqualified at the Promoter's discretion.
- 3.3 Entrants must provide correct personal information including full name, contact number, and suburb. Entries that are incomplete, incorrect or misleading may be deemed invalid.
- 3.4 Entrants may only enter using their own personal details. Using multiple identities, phone numbers, email addresses or false information may result in disqualification.

4. Call-Outs & Finalist Selection

- 4.1 Callouts will commence Tuesday 27th January 2026.
- 4.2 When an entrant's name is called on-air, they must call 97.3 Coast FM Studio (9581 5973) within 97 minutes to claim a finalist position.
- 4.3 If they do not call back within 97 minutes, a Second Chance Swoop will occur. Once the

Swoop Cue plays, the first random eligible caller will take that finalist place.

4.4 A total of twenty (20) finalists will be selected at random from the standby list. Each finalist will receive one (1) unique 4-digit Safe Code for use at the final event.

5. One Finalist Per Household - Eligibility Restriction

- 5.1 Only one (1) finalist per household is permitted for the duration of the promotion. A "household" is defined as all individuals residing at the same residential address, regardless of surname, tenancy arrangement or familial relationship.
- 5.2 The Promoter reserves the right to request evidence of address (e.g., driver's licence, utility bill, lease agreement), verify personal information supplied, and disqualify any entrant who provides false, misleading or incomplete information, including but not limited to falsifying an address, using multiple addresses, or attempting to bypass the one-finalist-per-household rule.
- 5.3 If a finalist is disqualified under this clause, the Promoter may re-award that finalist place at its sole discretion (including via a new call-out or Second Chance Swoop). The Promoter's decision is final and binding.

6. The Final Event - \$20,000 Safe Crack

- 6.1 The final event will take place on Thursday 5th March 2026 at Community Bank Halls Head.
- 6.2 Each finalist must check in with valid photo ID and will be assigned an attempt order. Finalists will then choose one (1) sealed envelope containing their unique code.
- 6.3 Envelopes must remain sealed until the finalist is called to attempt the safe. Envelopes are identical and distributed at random.
- 6.4 Each finalist will open their envelope when instructed and enter their unique code into the Coast FM safe.
- 6.5 Only one (1) code will unlock the safe. The finalist whose code opens the safe will be declared the winner.
- 6.6 The prize consists of a bank account established in the winner's name with Community Bank, Halls Head (Bendigo Bank), containing a deposit of \$20,000.
- 6.7 To receive the prize, the winner must meet all requirements of Bendigo Bank to open an eligible account in their own name.
- 6.8 If the winner is under 18 years of age, or is otherwise unable to open a bank account independently, the prize may be awarded to the winner's parent or legal guardian upon satisfactory proof of identity and subject to Bendigo Bank's account requirements.

7. General Prize & Eligibility Conditions

- 7.1 A listener (or household) may win only one prize within a 60-day period, unless otherwise stated in Coast FM's General Terms and Conditions.
- 7.2 The Promoter reserves the right to disqualify entrants who breach eligibility requirements or attempt to manipulate the competition.

- 8.2 Entrants, finalists and winners agree to participate in publicity, photographs, interviews and promotional material as reasonably requested by the Promoter without compensation.

10.1 If for any reason this competition cannot run as intended (including technical failure, tampering, fraud, or unforeseen events), the Promoter reserves the right to modify, suspend or cancel the competition.
