



### The Duck/Big 107.7 Paul McCartney Giveaway Rules

NO PURCHASE NECESSARY AND NO ENTRY FEE, PAYMENT OR PROOF OF PURCHASE IS NECESSARY TO PARTICIPATE.

OPEN TO INDIVIDUALS WHO, AS OF THE TIME OF SELECTION, ARE AT LEAST 18 YEARS OLD, ARE LEGAL RESIDENTS OF MARYLAND, DELAWARE, OR VIRGINIA AND HAVE THEIR PRIMARY RESIDENCE ON THE DELMARVA PENINSULA AS DEFINED BY THE STATE OF DELAWARE AND THE EASTERN SHORE OF MARYLAND AND EASTERN SHORE OF VIRGINIA.

The Duck/Big 107.7 Paul McCartney Giveaway (“**Sweepstakes**”) begins on April 13, 2022 and ends on June 4, 2022. This Sweepstakes is sponsored by WTDK-FM and WGBG-FM, 1729 N. Salisbury Blvd., Salisbury, MD 21801 (“**Sponsor**”).

To enter for a chance to qualify, entrants must register in person at either Vernon Powell Shoes location from 12:00 PM on April 13, 2022 to 12:00 PM on June 2, 2022 (**Round 1 Qualifying Period**) during regular business hours. Vernon Powell Shoes is located at 2401 E. Naylor Mill Road, Salisbury, MD 21804 or 18798 Coastal Hwy, Rehoboth Beach, DE 19971. Two (2) qualifiers will be drawn from entrants at each location at approximately 12:00 PM on the following Thursdays during the Sweepstakes (April 21, 28; May 5, 12, 19, 26; June 2). There will be a total of four (4) qualifiers per week. There will be a total of 28 qualifiers during the Round 1 Qualifying Period. Entry deadline at both Vernon Powell Shoes locations for the Round 1 Qualifying Period is 12:00 PM on June 2, 2022.

Entrants may also register in person for a chance to qualify at the Salisbury Vernon Powell location (2401 E. Naylor Mill Road, Salisbury, MD 21804) from approximately 11:00 AM – 12:30 PM on June 4, 2022 (**Round 2 Qualifying Period**). There will be a total of 2 randomly selected qualifiers during the Round 2 Qualifying Period.

All qualifiers will win a \$50 Vernon Powell Shoes Gift Card and be entered into the Grand Prize/Runner-up drawing to be held as defined in these rules. Odds of winning a qualifying prize via in person registration at Vernon Powell Shoes will be determined by the number of entries received. All Round 1 entries will remain eligible for the duration of Round 1 but will not be included in Round 2 registration. One entry per person per round.

Grand Prize and Runner-up Prize: Two winners will be randomly drawn from all thirty (30) qualifiers on or about Saturday, June 4, 2022 at 12:45 PM, each winning a pair of tickets to the June 12<sup>th</sup> Paul McCartney concert at Oriole Park at Camdem Yards in Baltimore, MD . Entrants must be present in order to win. Odds of winning a Grand Prize or Runner-up Prize will be determined by number of Qualifiers present.

By participating, entrants agree to be bound by these official rules and by the decisions of the in all matters relating to the Sweepstakes. All decisions made by Sponsor are final.

No purchase necessary. Must be 18 years of age or older to enter. The Sweepstakes is open only to legal residents of Maryland, Delaware, and Virginia whose primary residence is on the Delmarva peninsula as defined by the State of Delaware and the Eastern Shore of Maryland and Eastern Shore of Virginia. Void where prohibited or restricted by law. Employees, contractors, directors, officers, consultants, and representatives of Draper Holdings, Vernon Powell Shoes, local sponsors, their subsidiaries, affiliates (“**Sweepstakes Parties**”) and each of their immediate relatives and those living in the same household of each are not eligible to participate. One (1) Runner-up Prize: 2 tickets to the Paul McCartney “Got Back” concert on June 12, 2022 at 8:00 PM, Section 206, Row 1, Seats 5 & 6 (ARV \$355.84)

The approximate retail value (“**ARV**”) of each prize is as set forth above. A total of 32 prizes will be awarded with a total ARV of \$2,612.88 for all prizes.

All prizes (Qualifying, Grand, and Runner-up) must be picked up by the winner in person at the Vernon Powell, located at 2401 E. Naylor Mill Road, Salisbury, MD 21804 on June 4, 2022 no later than 1:00 PM (“**Claim Period**”). Proper identification in the form of a passport, driver’s license, or other form of government-issued picture identification must be presented to Sponsor in order for a winner to claim a prize. All prize claims are subject to verification of winner’s eligibility. No one may claim a prize other than the
