

Draper Media One Magical Summer Giveaway

NO PURCHASE NECESSARY AND NO ENTRY FEE, PAYMENT OR PROOF OF PURCHASE IS NECESSARY TO PARTICIPATE.

OPEN TO INDIVIDUALS WHO, AS OF THE TIME OF SELECTION, ARE AT LEAST 21 YEARS OLD, ARE LEGAL RESIDENTS OF MARYLAND, DELAWARE, OR VIRGINIA AND HAVE THEIR PRIMARY RESIDENCE ON THE DELMARVA PENINSULA.

The disc jockey on air will take the 25th caller, who will then be qualified to win the One Magical Summer Giveaway Grand Prize. Each station will award 20 qualifiers over the air during the Call-in Qualifying Period.
