



## **Draper Media Radio Bingo Giveaway**

NO PURCHASE NECESSARY AND NO ENTRY FEE, PAYMENT OR PROOF OF PURCHASE IS NECESSARY TO PARTICIPATE.

OPEN TO INDIVIDUALS WHO, AS OF THE TIME OF SELECTION, ARE AT LEAST 18 YEARS OLD, ARE LEGAL RESIDENTS OF MARYLAND, DELAWARE, OR VIRGINIA AND HAVE THEIR PRIMARY RESIDENCE ON THE DELMARVA PENINSULA.

### **1. Sponsor and Contest Period**

The Radio Bingo Giveaway (“**Contest**”) begins on Monday, September 29, 2025, and ends on Thursday, November 6, 2025 (the “**Contest Period**”). This Contest is sponsored by Draper Media, 1729 N. Salisbury Blvd., Salisbury, MD 21801 (“**Sponsor**”).

### **2. Participating Stations and Websites**

Radio Bingo will air on the following Draper Media radio stations (each a "Station," collectively, the "Participating Stations"). The Contest page to enter and upload your Bingo Card photo will be located on each Station website listed below.

### **3. How to Play and Enter**

#### **A. On-Air Callouts**

Listen weekdays during the Contest Period from 6:00 AM to 6:00 PM Eastern Time. Approximately once each hour, a Station will announce a Radio Bingo "number" or callout (each a "Callout"). When you hear a Callout, write the date and time you heard it in one open square on your Radio Bingo Card. Each square must include the date, the approximate time, and the Station you were listening to.

A valid Bingo occurs when you have filled five squares in a straight line, which may be horizontal, vertical, or diagonal (a "Valid Bingo").

#### **B. Get a Bingo Card**

You may download a Radio Bingo Card from any Participating Station website or pick one up at an upcoming Radio Bingo Card Stop listed in Section 4. No purchase is required to obtain a card.

### **C. Submit Your Entry**

Once you have a Valid Bingo, complete the entry form and upload a clear photo of your card on the Contest page of any Participating Station website during the applicable Weekly Entry Period defined in Section 5. Entries must include your full name, mailing address, ZIP code, email, phone number, and birthdate.

Limit one Bingo entry per person for the entire Contest, regardless of the number of Valid Bingos obtained. Limit one Weekly Prize per person for the entire Contest. Entries that are incomplete, illegible, late, or contain false or unverifiable information will be void. Sponsor may verify entries using Station logs and other methods.

### **4. Radio Bingo Card Stops**

You can also pick up a Bingo Card at any of the following Card Stops. Attendance is not required to enter or win.

Times and locations are subject to change. Any updates will be announced on air and on the applicable Station website.

### **5. Weekly Drawings and Entry Periods**

For purposes of the Weekly Prize drawings, the Contest is divided into separate Weekly Entry Periods. Each Weekly Entry Period runs from Monday at 12:00 AM ET through Sunday at 11:59 PM ET. Weekly drawings will be conducted for the weeks beginning 9/29/2025, 10/6/2025, 10/13/2025, and 10/20/2025. The final Weekly Entry Period ends Sunday, 10/26/2025, at 11:59 PM ET.

Each of those weeks, Sponsor will conduct one random drawing from all eligible entries received during that Weekly Entry Period to award one Weekly Prize. There will be exactly four (4) Weekly Prize drawings in total. Odds of winning a Weekly Prize depend on the number of eligible entries received that week.

Weekly Prize winners will be notified by phone and or email within two business days after the drawing. If a selected winner cannot be contacted, fails to respond within 24 hours, or is deemed ineligible, an alternate may be selected at Sponsor's discretion.

### **6. Grand Prize Event**

The Grand Finale will consist of in-person Bingo games. Participation in the Grand Finale is by invitation only. Sponsor will conduct a random drawing to select one hundred (100) invitees from among all entrants who have submitted a Qualified Radio

Bingo Card as described in Section 3 and received by 11:59 PM ET on Sunday, November 2, 2025. Odds of receiving an invitation depend on the number of Qualified Radio Bingo Cards received by the deadline.

Invited entrants will be notified by phone and or email. Invitees must confirm attendance within 24 hours of notification; failure to timely confirm, failure to meet eligibility requirements, or failure to respond will result in forfeiture of the invitation, and an alternate invitee may be selected at Sponsor's discretion.

- Date and time: Thursday, November 6, 2025, from 6:00 PM to 8:00 PM ET
- Location: Tyndall's Casual Furniture, Laurel, Delaware

A Finale Bingo card will be provided at check-in. Only invited attendees who check in between 6:00 PM and 6:45 PM ET and present a valid photo ID may participate. Three (3) Bingo games will be played in order:

1. **Game One: "X" pattern**  
Prize: Poconos trip prize basket. Approximate Retail Value ARV \$1,750.
2. **Game Two: "Four Corners"**  
Prize: Poconos trip prize basket. ARV \$1,750.
3. **Game Three: "Cover All"**  
Prize: \$1,500 cash Grand Prize. ARV \$1,500.

Sponsor will announce the specific game rules and any tie breaking procedures prior to each game. You must be present to win.

## **7. Streaming Delay Warning**

Listeners who hear the Stations through online streams may experience delays that vary based on device, buffering, and internet connection. To participate in real time, use a conventional FM radio. Streaming delays may last several minutes. Online listeners may be at a disadvantage compared to over the air listeners when attempting to hear Callouts.

## **8. Prizes**

- Weekly Prize: Five hundred dollars \$500, awarded as a check. There will be four 4 Weekly Prizes in total, one per week during the Weekly Entry Periods specified in Section 5. ARV \$500 each.
- Finale Prize One: Poconos trip prize basket awarded to the winner of the "X" pattern game. ARV \$1,750.
- Finale Prize Two: Poconos trip prize basket awarded to the winner of the "Four Corners" game. ARV \$1,750.
- Grand Prize Final Game: \$1,500 cash awarded to the winner of the "Cover All" game. ARV \$1,500.

Total ARV of all prizes: \$7,000.

All prizes must be claimed as directed by Sponsor. Prizes are non-transferable and may not be substituted, except that Sponsor may substitute a prize of equal or greater value in its sole discretion. No cash equivalents will be offered other than as expressly stated.

## **9. Eligibility and Restrictions**

The Contest is open only to legal residents of Maryland, Delaware, and Virginia whose primary residence is on the Delmarva Peninsula. Void where prohibited or restricted by law. Employees, contractors, directors, officers, consultants, and representatives of Draper Media, Draper Holdings, Tyndall's Casual Furniture, all Radio Bingo Card Stop businesses listed in Section 4 (including Morse Roofing and Siding, Beach Barrels, Primo Hoagies, Grocery Outlet Market, Furniture Gallery, Scrub Apparel, and Camco Auto), local sponsors, their subsidiaries and affiliates (collectively, the "Contest Parties") and each of their immediate family members and those living in the same household of each are not eligible to participate.

Each individual may submit no more than one Bingo entry per Weekly Entry Period. There is a maximum of one Weekly Prize per person, household, address, phone number, and email for the entire Contest. Winners of a Weekly Prize remain eligible to attend the Grand Prize Event.

This Contest is not intended to be used for gambling purposes. If it is determined that a participant is using the Contest for gambling, that participant will be disqualified.

By participating, entrants agree to be bound by these official rules and by the decisions of the Sponsor in all matters relating to the Sweepstakes. All decisions made by Sponsor are final.

Checking the box to receive offers from any of the participating radio stations or any Draper Media property and/or liking their respective social network pages are not required in order to participate in the giveaway.

No purchase necessary. Must be 18 years of age or older to enter. Winner cannot have won a prize in any other Sweepstakes/Contest sponsored by the participating radio stations, whether on radio, TV, online or mobile, within 30 days from the date of his or her selection to win a second prize.

The prize is non-transferable, and no prize substitution is permitted, except at the sole discretion of the Sponsor.

A list of winners will be posted on each participating radio station's website by November 10, 2025 and shall be available for up to thirty (30) days after the end of this Contest.

## **10. Taxes and Documentation**

Any personally identifiable information collected during participation in the Contest will be collected by Sponsor or its designee and used by Sponsor and its affiliates for purposes of the proper administration and fulfillment of the contest and as otherwise set forth in these rules. Sponsor reserves the right to use such information to provide winners with newsletters and other promotional material. Winners may opt-out of such communications by contacting Sponsor, as applicable.

Sponsor reserves the right to modify or supplement these rules at any time.
