Following the deaths of two local firefighters during a tragic local fire, Momentum Broadcasting did live broadcasts on 2/19/20, 2/20/20, 2/21/20, and 2/22/20 in order to raise support.		
The stations made banners for the community to sign condolence wishes, which were then presented to the Fire Department. The stations also sold t-shirts to raise money for the families of the fallen firefighters, raising \$22,000 for their expenses. Air personalities were on hand to explain the effort to the community and answer questions for those who might be interested in the radio business.

We decided that we would run the program starting late April to commence with the uptick in activity throughout the radio stations that comes from the commencement of our promotional activities, particularly on KIUG and KCRZ, but on KIOO and KVMJ as well to a lesser degree. With that in mind we choose two individuals that expressed interest in internships for interviews, with the idea that we would choose one. In the interest of privacy their names are withheld, one a female attending Fresno State for Communications, and an interest in Business, the other a male attending College of the Sequoias seeking a degree in Music, and an interest in the Recording Arts Engineering specialty. Interviews were conducted the afternoon of February 5th, 2020. We liked both the candidates so much, and they both seemed legitimately interested in an internship, that internally we decided that we would bring them both in. We informed them that we would like to bring them both and, had internal department head level meetings to discuss what the program we would set up for them would look like, so we could bring them both in at once. Since then this entire program has been shut down effective March 18, when all but the most essential of employees were sent home. Since that time we are attempting to minimize outside contact with staff. We have had one employee acquire SARS -2, and subsequently was out of work and office for 5 weeks. As long as Tulare County is experiencing a significant SARS-2 impact it seems unlikely we can, in the interest of safety for existing staff, have outside non-employees in the building in close proximity to staff.</p>
