**Online Public Inspection File**

Licensee believes that the Online Public Inspection File (“OPIF”) of KCRZ is substantially complete and that throughout the license term it substantially complied with the FCC’s rules regarding the OPIF. Nonetheless, Licensee cannot certify that all required documents were uploaded to the OPIF in a timely manner. Specifically, Licensee failed to upload a number of KCRZ’s Quarterly Issues/Programs Lists and its 2017-2018 Annual EEO Report; those documents were all subsequently added to the OPIF after those deadlines.

Licensee also is unable to certify that during the applicable retention period all documentation required to be uploaded to KCRZ’s Political File was uploaded in a complete and/or timely manner, although it believes that it substantially complied with the Commission’s Political File rules. Licensee will continue to review its procedures for posting to the online Political File and will endeavor in the future to completely comply with KCRZ’s Political File reporting requirements in a timely manner.

Licensee is also unable to certify that at all times it maintained an up-to-date list of the documents required to be maintained under Section 73.3613 of the Commission’s rules in KCRZ’s OPIF, although Licensee believes that a current list of such documents was available in Licensee’s ownership reports at most times during the license term. A note has been added to KCRZ’s OPIF referring visitors to Licensee’s most recent ownership report for a current list of the requisite Section 73.3613 documents.
